Vice President Jonell Guzman reminded the members that the Know your Rights Workshop is coming up and she asked to be e-mailed with questions regarding this event.




Vice President (Norco) Tamara Caponetto motioned to adjourn the meeting and union member Louis Tamayo seconded.
