#### **NEW COURSES**

The following courses have been added to the Riverside City College course catalog.

#### COS-60A1 Cosmetology Concepts Level A1 5.5 units

#### Prerequisite: None

An introduction to beginning cosmetology concepts Level I section 1, California Board of Barbering and Cosmetology Act and Regulations, cosmetology related sciences, and the practice of cosmetology principles. Theory subjects include health and safety, cosmetology related sciences, level I hair care, skin care and nail care. Laboratory practices include health and safety, level I hair care, skin care, and nail care. Due to the State Board of Barbering and Cosmetology licensing regulations agency, this course has an hour requirement and some of the course content is similar or repeated content to the A2 course. 72 hours lecture and 93 hours laboratory. (Letter grade only)

#### COS-60A2 Cosmetology Concepts Level A2 5.5 units

#### Prerequisite: None

An introduction to beginning cosmetology concepts Level I section 2, California Board of Barbering and Cosmetology Act and Regulations, cosmetology related sciences, and the practice of cosmetology principles. Theory subjects include health and safety, cosmetology related sciences, level I hair care, skin care and nail care. Laboratory practices include health and safety, level I hair care, skin care, and nail care. Due to the State Board of Barbering and Cosmetology licensing regulations agency, this course has an hour requirement and some of the course content is similar or repeated content to the A1 course. 72 hours lecture and 93 hours laboratory. (Letter grade only)

#### COS-60B1

#### Cosmetology Concepts Level B1 5 units

#### Prerequisite: COS-60A1 and COS-60A2 or COS-60A

Level II section A cosmetology related sciences and the practice of cosmetology principles. Theory subjects include health and safety, cosmetology related sciences, level II hair care, skin care and nail care. Laboratory practices include health and safety, level II hair care, skin care, and nail care. Due to the State Board of Barbering and Cosmetology licensing regulations agency, this course has an hour requirement and some of the course content is similar or repeated content to the B2 course. 63 hours technical instruction and 102 hours laboratory. (Letter grade only)

COS-60B2 Cosmetology Concepts Level B2

#### 5 units

#### Prerequisite: COS-60A1 and COS-60A2 or COS-60A

Level II section B cosmetology related sciences and the practice of cosmetology principles. Theory subjects include health and safety, cosmetology related sciences, level II hair care, skin care and nail care. Laboratory practices include health and safety, level II hair care, skin care, and nail care. Due to the State Board of Barbering and Cosmetology licensing regulations agency, this course has an hour requirement and some of the course content is similar or repeated content to the B1 course. 63 hours technical instruction and 102 hours laboratory. (Letter grade only)

#### COS-60C1 Cosmetology Concepts Level C1 5 units

#### Prerequisite: COS-60B2 and COS-60B1 or COS-60B

Level III section 1, study of California Board of Barbering and Cosmetology Act and Regulations, cosmetology related sciences and the practice of cosmetology principles. Theory subjects include health and safety, level III cosmetology related sciences, level II hair care, skin care, and nail care. Laboratory practices include health and safety, hair care, skin care, and nail care. Due to the State Board of Barbering and Cosmetology licensing regulations agency, this course has an hour requirement and some of the course content is similar or repeated content to the C2 course. 54 hours technical instruction and 111 hours laboratory. (Letter grade only)

#### **COS-60C2**

#### Cosmetology Concepts Level C2 5 units

#### Prerequisite: COS-60B1 and COS-60B2 or COS-60B

Level III section 2, study of California Board of Barbering and Cosmetology Act and Regulations, cosmetology related sciences and the practice of cosmetology principles. Theory subjects include health and safety, level III cosmetology related sciences, level II hair care, skin care, and nail care. Laboratory practices include health and safety, hair care, skin care, and nail care.Due to the State Board of Barbering and Cosmetology licensing regulations agency, this course has an hour requirement and some of the course content is similar or repeated content to the C1 course. 54 hours technical instruction and 111 hours laboratory. (Letter grade only)

#### COS-60D1

#### Cosmetology Concepts Level D1 4 units

#### Prerequisite: COS-60C1 and COS-60C2 or COS-60C

Level IV section 1, study of California Board of Barbering and Cosmetology Act and Regulations, cosmetology related sciences and the practice of cosmetology principles. Theory subjects include health and safety, level IV cosmetology related sciences, advanced level IV hair care, skin care and nail care. Laboratory practices include health and safety, level IV hair care, skin care, and nail care. Due to the State Board of Barbering and Cosmetology licensing regulations agency, this course has an hour requirement and some of the course content is similar or repeated content to the D1 course. 27 hours lecture and 138 hours laboratory. (Letter grade only)

#### COS-60D2

#### Cosmetology Concepts Level D2 4 units

#### Prerequisite: COS-60C2 and COS-60C1 or COS-60C

Level IV section 2, study of California Board of Barbering and Cosmetology Act and Regulations, cosmetology related sciences and the practice of cosmetology principles. Theory subjects include health and safety, level IV cosmetology related sciences, advanced level IV hair care, skin care and nail care. Laboratory practices include health and safety, level IV hair care, skin care, and nail care. Due to the State Board of Barbering and Cosmetology licensing regulations agency, this course has an hour requirement and some of the course content is similar or repeated content to the D1 course. 27 hours lecture, 138 hours laboratory. (Letter grade only)

#### **MUS-854**

# Jazz Ensemble for Older Adults 0 Units

Study, rehearsal, and public performance of literature written for jazz ensemble, with an emphasis on the development of music performance skills for older adults. Different literature will be studied each semester. 54 hours laboratory. (TBA option)

#### **MUS-855**

#### **Concert Band for Older Adults** 0 Units

Prerequisite: None

Study and rehearsal of concert band literature, with an emphasis on the development of music performance skills for older adults. Different literature will be studied each semester. 54 hours laboratory. (TBA option)

#### **MUS-868**

#### **Symphony Orchestra for Older Adults** 0 Units

Study, rehearsal, and public performance of orchestral literature, with an emphasis on the development of music performance skills for older adults. Different literature will be studied each semester. 54 hours laboratory. (TBA option)

#### **NEW PROGRAMS**

#### COMMUNITY ACTION AND LEADERSHIP ACADEMY

This certificate program is tailored to the Community Action Leadership Academy (CALA), to which students must apply and be accepted. CALA is open to all majors. This program of courses will satisfy the "learn" aspect of the "learn and earn" model that is the foundation of the CALA internship experience. It will provide training and knowledge on issues of social justice, leadership, communication skills, and nonprofit advocacy. Course requirements for the certificate are one required internship course, a personal development or life/ career planning guidance course, and an Ethnic Studies course. Students are recommended and counseled in the academy to take additional courses based on their interests and major varying from the skills and themes, which comprise effective community non-profit advocacy.

Students can be certified by the faculty coordinator or designee for the CALA certificate after successfully completing the courses and participating in a compensated year-long, non-profit internship in the community rooted in social justice.

#### **Program Learning Outcomes:**

Upon successful completion of this program, students should be able to:

- Provide academic opportunities to learn and apply community history and wealth of knowledge.
- Allow students to connect important field experiences with academic theory and policy.
- Analyze the systemic barriers affecting social justice work in students' communities.
- Assist in student retention via cohort style, academy learning opportunities.
- Deepen students' critical thinking and problem-solving skills regarding real world leadershipscenarios and community engagement.

#### COSMETOLOGY(R) AS534/AS534B/AS534C/CE534

### The following program has been modified effective summer 2022.

This program prepares individuals to provide professional cosmetic services in salons, resorts, casinos, dermatologist's offices and other related industry establishments. This includes courses in hair design, hair sculpting, chemical, esthetic and other cosmetic services, safety and sanitation, management, customer service, and preparation for practicing as licensed cosmetologist in the state of California. Courses in applicable professional labor laws and regulations in the cosmetology industry, physiology, anatomy, electricity and ergonomics are also covered in depth. Emphasis is placed on passing state licensing exam and industry entry skills.

#### **Program Learning Outcomes**

Upon successful completion of this program, students should be able to:

- Deduce valid conclusions, compare and contrast viable techniques and apply principles in preparation of the California State Board of Barbering and Cosmetology practical and written exam.
- Identify and analyze concepts leading to synthesis of theory for the state board written exam.
- Produce a business plan and portfolio.
- Demonstrate entry-level industry skills in a clinic laboratory setting.
- Demonstrate workplace behaviors ("soft skills") necessary for success in the cosmetology industry.
