

Student Drop Analysis August 22 to 23 2021 Wendy McEwen Dean, Institutional Effectiveness

Riverside Community College District mandated that all students enrolled in on-campus classes be vaccinated for COVID before August 19th, 2021. The messaging to students included information that if the student must upload proof of vaccination into the Cleared4 application prior to this date or be dropped (automatically disenrolled) from face-to-face courses.

Riverside City College's Office of Institutional Effectiveness is looking at the impact this drop has had with an equity lens as well as within certain academic disciplines. This report shares initial findings based on enrollment as of August 22, 2021 and enrollment as of August 23, 2021 at 7:37 am. The data files used for this enrollment were provided by the District Institutional Research Office.

Overall, the COVID-19 vaccination deadline drop resulted in a loss of 10.5% of RCCD students with RCC losing 11.5%. The course count drop (total of courses dropped) was slightly less than the unique headcount. Table 1 shows the unique student headcount drop and Table 2 shows the drop by total courses.

One specific concern about the COVID-19 vaccination included the potential disproportionate impact on RCC student populations. Initial data shows that this drop did have a higher impact on African American students. From August 22nd to August 23rd, African American students had the highest percentage of drops by student (15.3%) and also the second highest number of course drops (14.8%).

By Academic Division, RCC's STEM & Kinesiology Division had 14.3% of its course enrollment dropped. By Department, Applied Technology lost the most course enrollment – 21.0%. Tables 5 and 6 have drop information by Division and Department.

At the course level, ENG-1A and MAT-12 courses lost the most students by headcount. For both courses, African American student drop rates were higher than the overall course drop rates.
